YOUTH FIREFIGHTER CAMP

June 22-26, 2020; 9 a.m. to 12 p.m.

Ages 6-13 years of age (Must be 6 yrs of age by start of camp)

Registration Fee: \$40; deadline to register: February 29, 2020

Welcome to Limerick Fire Department's Youth Firefighter Camp. Due to the success of our camp, the deadline to register cannot be extended and attendance is limited.

All registered cadets will receive one LFD Fireman's t-shirt and one LFD athletic shorts to wear as their 'daily uniform'. The 'uniform shirt' must be worn every day because it identifies which group the cadet is assigned to for the week. If you are interested in purchasing extra camp shirts, they must be ordered at the time of registration - \$10 per shirt.

Why try *this* Camp? You child will:

- ▶ Learn fire safety you thought you knew & then apply what you've learned
- ▶ Learn about the fire department, trucks (apparatus), and personnel
- ▶ Hands-on with various equipment
- ▶ Ladders-learn the how-to's
- ▶ Hoses-proper techniques to connect to the hydrant, flow water, roll up, etc.
- ▶ Extinguishers-the ABC's
- ▶ Rescue tools-hands-on and during simulated live demonstrations
- ▶ Fire gear-bunker pants, jacket, helmet, safety gloves & glasses all provided
- ▶ Watch & participate in several live demonstrations with the firefighters
- ▶ And so much more....

We require closed-toed shoes/sneakers every day. Open-toe shoes & flip flops are not permitted.

Camp will go on if there is rain or excessive heat. We will take necessary safety measures.

Each adult MUST walk their camper to the sign in station and sign the camper in with staff. No camper is allowed to sign themselves into camp. If someone other than the parent/parties on the registration form is picking up the camper, a note MUST be sent in at the time of morning drop off. This person must also show a valid photo ID when picking up.

Thank you for help keeping your child safe. We appreciate your understanding.

It happens – you're running late. We understand that sometimes extenuating circumstances prohibit a parent from picking up a child on time. However, we are also concerned with fairness to our volunteer firefighter staff. Please call Camp Coordinator Kara Shuler at 484-390-1838 immediately upon knowing of your delayed arrival.
